CUB phone session planned at church

HUNTLEY – The Citizens Utility Board's "Right Call Campaign" will be in Huntley on Thursday to help consumers learn how to cut their calling costs by hundreds of dollars a year.

The clinic will be at 7 p.m. Thursday at Faith Community Church, 10547 Faiths Way, Huntley.

At the clinic, consumers will learn about:

- The CUB Cellphone Saver, an online tool that analyzes individual wireless bills. It has been shown to save consumers an average of \$300 a year.
- The CUB-designed Consumer's Choice local-calling plans that AT&T is forced to offer under a legal settlement. Most consumers can save money with them.
- Illinois' best long-distance plans, including how to get an automatic \$20 credit that CUB negotiated. That amounts to nearly 11 hours of free calls.

Attendees should bring their phone bills so CUB experts can analyze them and provide tips on how to cut them.
