Home Energy Rebate Program

Peoples Gas and North Shore Gas customers who are owners of single-family homes, two-flats and individually-metered condos, apartments and town homes can get rebates on a wide range of energy-saving improvements to their homes.

- New equipment must be installed and old equipment removed.
- Only new products that meet or exceed the standards listed on the application form qualify for a rebate. Complete details of terms and conditions can be found in the application forms at www.smartenergy-zone.com/PG-NSG/.

Rebate Program Requirements:

- Program dates: May 31, 2017 - December 31, 2017
- Applications must be received within 30 days of installation date to be eligible
- Eligible products must be purchased through professional contractors, in accordance with manufacturer specifications and state and local codes.

Illinois Energy Efficiency Loan Program

Eligible Peoples and North Shore Gas customers can receive a low-interest loan to purchase a high-efficiency furnace

Water Heater-Indirect	88% AFUE or greater	\$150
Programmable Thermostat	Must be self-installed	\$20
Smart Thermostat	Must be a qualifying thermostat: ecobee3, ecobee4, Nest, Allure EverSense, Honeywell Lyric, Lennox iComfort S30, Radio Thermostat CT50, Radio Thermostat CT80, LUX/GEO	\$50 Additional \$100 smart thermostat rebates available for eligible ComEd customers
Air Sealing	Must be installed by an approved weatherization contractor (http://www.peoplesgasdelivery.com/home/pdf/rebates_residential_comed.pdf)	40 cents/CFM Reduction (capped at \$400)

Wall Insulation	Applies to exterior or above grade foundation wall (Must be bundled with air sealing and installed by an approved weatherization contractor)	50 cents/square foot (capped at \$400)
Attic Insulation	Existing insulation must be R11 or less and installed insulation must be R49 or greater (Must be bundled with air sealing and installed by an approved weatherization contractor)	30 cents per square foot, up to \$300 for each project
Duct Sealing	Must be installed by an approved weatherization contractor	\$2/CFM Reduction (capped at \$500)

and then make monthly installment payments on their gas bill. A loan through the Illinois Energy Efficiency Loan Program can be paired with a rebate for a qualifying furnace.

Who can apply?

Residential customers of Peoples or North Shore Gas who own a:

- Single-family home;
- Condo; or
- Multi-family building with no more than four units.

What are the loan details?

- No down payment required
- Loans of \$500 to \$20,000
- 4.99% fixed rate interest
- Terms of 3, 5 or 10 years
